DISPENSING

- Sika[®] UCS should not be added to the mixing water. it can usually be added at the batching plant with the aggregate for dispersion instead.
- After dry mix, A wet mixing time is depending on the mixing conditions and mixer performance, of at least 90 seconds is recommended.

For calculation of the proper water amount, the exact dosage of the Sika[®] UCS/superplasticizer and the final demanded concrete properties have to be taken into account.

In all cases before application, suitability tests must be performed.
