DESCRIPTION

Sikaplast[®]-194 is a 3rd generation polymer based high performance superplasticizer for producing soft consistency concrete.

Sikaplast®-194 meets the requirements of ASTM C 494 Type D & G

Sikaplast®-194 conforms to Type G when used at 0.8 - 1.0% dosage, depending on cement type used.

USES

Sikaplast[®]-194 is mainly suitable for the manufacture of concrete for RMC plants and site batch concrete Sikaplast[®]-194 is used for the following types of concrete:

- Bored piles
- Barrette foundations and diaphragm walls
- Ground and suspended slabs

CHARACTERISTICS / ADVANTAGES

Sikaplast[®]-194 combines different modes of actions. By adsorption on the surface of the fines and keeping them apart while the hydration is in progress, Sikaplast[®]-194 effects the following concrete properties:

- Long slump keeping and high water reduction
- Compatible with SCM like GGBSF, PFA
- High flowability (considerably reduced placing and compacting work)
- Faster evolution of early strength development
- Workability can be maintained up to 3-6 hours (still depends on admixture dosage, cement type, temperature)
- Improved creep and shrinkage resistance characteristics
- When used at higher dosages, Sikaplast[®]-194 can give extended working time

Concrete placing: With the use of SikaPlast[®]-194, concrete of highest quality is being produced, however state of the art concrete technology, such as mixing, placing vibrating and curing must be respected and applied

Product Data Sheet Sikaplast®-194 December 2020, Version 02.01 021301011000003753 Sikaplast[®]-194 is added to the gauging water prior to its addition to the dry mix or added separately to the wetted concrete mix. For optimum utilization of the high range water reducer we recommend a

minimum wet mixing time of 60 seconds. When adding the balance of the batching water to adjust concrete consistency this should be done after a minimum of 2/3 of the wet mixing time to avoid surplus water in the concrete.
