A concrete plasticizer and retarder based on modified lignosulfonates used to produce good quality concrete. Complies with ASTM C494 Type D.

USES

Sikament® R-7 N is used in concrete where longer setting times and improved workability are required, such as projects with:

- Large pours, to prevent formation of cold joints;
- Long travel times from the concrete plant to the site;
- On site mixing;
- High ambient temperature.

CHARACTERISTICS / ADVANTAGES

- Only set retarding, does not delay the hardening process:
- Allow cement reduction compared to plain concrete;
- Increase in ultimate strength;
- Good control of slump loss even at elevated ambient temperature;
- Reduced shrinkage and creep;
- Chloride free, does not attack reinforcement steel.

APPLICATION INFORMATION

Recommended Dosage	0.3–0.8 L per 100 kg of cement (depend on cement type & brand) Typical dosage: 0.4–0.6 L per 100 kg of cement Overdosing: When overdosed, setting time will be extended, depending on cement content and temperature. Final strength will be not impaired. Note: Due to extended setting time, proper curing must be ensured. Do not vibrate green concrete or tamper embedded rebars whilst setting.
Compatibility	Possible to combine with all Sikament®, Sika® Aer, Sika® Pump, Sikacrete® PP-1, but must be added separately to the mix and not pre-mixed prior addition.
DISPENSING	Sikament® R-7 N is either added to the gauging water prior to its addition to the dry concrete mix or added separately to wetted concrete mix, further mixing should take place for at least 1 minute per m ³ .
