Compatibility	SikaPlast®-123 may be combined with all Sikament®, Sika® Aer, Sika®Pump, Sikacrete® PP1 products, but must be added separately to the mix and not pre-mixed prior its addition. SikaPlast®-123 is compatible with all Portland Cement types.

APPLICATION INSTRUCTIONS

DISPENSING

SikaPlast®-123 is added to the gauging water prior to its addition to the dry mix or added separately to the wetted concrete mix.

For optimum utilization of the ultra-high range water reducer we recommend a minimum wet mixing time of 60 seconds.

When adding the balance of the batching water to adjust concrete consistency this should be done after a minimum of 2/3 of the wet mixing time to avoid surplus water in the concrete.
